



Criteria and Application Form

The Criteria

Application criteria for the funds:

- The applicant must be a Plymouth based voluntary sector organisation or social enterprise
- Turnover must be less than £100,000 per annum
- We can only fund an organisation once in a 12month (Jan-Dec) period and groups can only receive two awards in a 3 year period.
- If required, priority will go to organisations who haven't already benefited from the fund already
- Applications are up to £200 per organisation
- The bursary must be used for training of Trustees / Directors, staff or volunteers
- Training must come from an external person or organisation, this fund is not for organisations to pay themselves to train their own staff, volunteers & trustees
- There is no requirement for match funding although the monies can be used to partially fund more expensive courses
- The courses do not need to be accredited
- We accept group applications from organisations partnering up please contact us to discuss this

Examples of training that we have funded include:

- Event stewards training
- Public speaking and presentation training
- Powerboat and safety boat training
- First aid training
- Level 1 Football coaching
- Level 1 Teaching Aquatics
- Chainsaw maintenance and use training
- Social media training
- Event management training
- Sage accounting training

Please Note: We don't fund training retrospectively.
